MORE-BAC-2025-002 Development of 30/36 MVA Gen. Hughes Substation

Change in the Approved Budget for the Contract (ABC)

After further consideration, MORE Power Bids and Awards Committee (BAC) hereby resolves to change the approved budget for the contract (ABC) in accordance with the revised changes in the *Scope of Work* in the *Terms of Reference:*

- 1. Addition of one (1) unit 80-ft. self-supporting steel pole;
- 2. Addition of one (1) unit 50-ft. self-supporting steel pole; and
- 3. Additional construction of transformer firewall.

Upon consultation with the TWG, these revisions constitute an additional **PhP 6 Million** to the original ABC of PhP 55 Million.

Therefore, the following inclusions, revisions, amendments, and adoptions are made on the following provisions in the Bid Documents:

<i>(additional item)</i> Section III: Scope of Work, Item 3.1.1.21	-	Supply, Delivery and Construction of a New Transformer Firewall. Th Contractor shall supply, deliver and construct approx. 8-meter high transformer firewall including its foundation consisting of concrete (211 kg/cm2), 6 inches CHB 600 psi Reinforcing Steel Bars (grade 275), Excavation and backfilling, Levelling concrete (141 kg/cm2), and other incidentals required to complete the works in accordance with the requirements and specifications indicated in the Tender Documents and approved plans and drawings.

The BAC further resolves that there shall be <u>no changes in the contract duration</u>, considering that the additional scope of work is not significant enough to affect the project timeline.

All terms, conditions and instructions to bidders specified in the Bidding Documents inconsistent with this Bid Bulletin are hereby superseded and modified accordingly.
